**Sub: Cadre Review of Medical Laboratory Staff of Four Central Government Hospitals/
Institutions of Delhi.**

The undersigned is directed to convey the approval of the Department of Expenditure, Ministry of Finance for the Cadre Review proposal of four Central Government Hospitals/ Institutions of Delhi under the Ministry of Health & FW, Government of India i.e. Safdarjung Hospital & VMMC, Dr. RML Hospital, LHMC & SSK Hospital and Kalawati Saran Children Hospital.

2. The Cadre review of Medical Lab staff of four Central Govt. hospitals of Delhi has been undertaken as per the decisions of the meeting of all concerned authorities of four Central Government hospitals, DGHS and MoHFW held under the Chairmanship of the Secretary, Health & FW on 11.12.2012 on the representation of Joint Forum of Medical Technologists of India (JFMTI) dated consequent to the decision of Hon'ble CAT (Principal Bench) New Delhi dated 1-8-2012 in O.A No. 2521/2012. All the modalities of the proposal sent to the Department of Expenditure were as per details provided by the Hospitals/Institutions and as deliberated in the meeting held on 11-12-2012. A copy of the minutes of the meeting held on 11-12-2012 and representation of JFMTI dated 18-9-2012 is enclosed.

3. Accordingly a cadre review proposal was sent to Department of Expenditure, Ministry of Finance. The detail regarding hospital-wise strength, designations, pay scales, qualification proposed by this Ministry and the approval received from Department of Expenditure, Ministry of Finance is as follows:-

Further Department of Expenditure, Ministry of Finance has advised the following-

- I. All 130 posts of lab attendants will be gradually phased out on functional ground.
- II. New grade of Chief Technical Officer (MLT) has been created for promotional avenues for Senior Technical Officer (STO) and managing the technical lab supervision of four central hospitals.
- III. Upgradation at level 2 & 3 of the above table has proposed to establish parity in pay scales for suitable placement as per their upgraded professional qualification.
- IV. There is a reduction of total 10 posts of Technical officer in the four Hospitals in the proportion i.e SJH (-3), RMLH (-4) and LHMC (-3).
- V. RRs for all these posts may be revised on priority basis as per the proposed qualifications, designations etc. in consultation with DoP&T. The Designations and the grade pay of all the posts may be revised as approved.

- VI. As decided in the meeting held on 24.05.2015, the proposal of MoHFW for all existing Medical Laboratory Staff at level 1 & 2 may be considered for promotion, on the basis of length of service based on DoP&T Guidelines.
- VII. Department of Expenditure, Ministry of Finance has also advised to form a common cadre of all Laboratory staff working in the four Central Government Hospitals with a new nomenclature and services rules.

4. The Cadre review proposal as approved by the Department of Expenditure, Ministry of Finance has been conveyed by them vide their Note No. MoF, DoE, ID No. 2(12)/E-III Desk/2013 dated 6th July, 2015, a copy of which is enclosed herewith. All concerned are hereby requested to implement the proposal approved by D/o Expenditure in a time bound manner as per the direction of Hon'ble CAT during hearing on 13.07.2015 to implement the order by 28th July, 2015. Implementation report in this regard should be furnished to the Ministry to enable this Ministry to apprise the same to Department of Expenditure, Ministry of Finance and the Hon'ble CAT (PB) New Delhi.
